Sir

I am directed to state that Govt. of India have been extending various facilities to Small Scale Industrial Units in the matter of Govt. Purchase Programme. Some of the facilities that have been extended to Small Scale Industries vide Govt. of India, Min. of Industries letter No. - SSI(P)-3(11)/84, dt. 31.5.84 is mentioned below:-

1. Earnest Money / Security Deposits need not be taken from the Small Scale Industries registered with the Directorate of Industries.
2. Tender sets must be given free of cost to Registered Small Scale Units.

In respect of items produced in the small scale sector, the decision of the Govt. implies that price preference would be extended upto 15% if the products of the small scale industries are otherwise acceptable in terms of quality & specification.

Thus, small scale units of A&N Islands are entitled to exemption from payments of earnest money, fee for tender documents and security deposits, if the units are registered with the Directorate of Industries, port Blair.

I am, therefore, to request you to comply with these instructions and implement the Govt. Purchase Policy and accord the above incentives to all Registered SSI Units registered with the Directorate of Industries, A&N Islands.
