5. To monitor the input and output, ie., whether the services and projects are being setup on schedule; and
6. To review the progress / achievement.

The Committee will meet at least once in every quarter after giving sufficient notice to the Hon'ble Member of Parliament [LS] and other members. The General Manager, District Industries Centre, A&N Administration will provide secretarial assistance to the committee.
