**NOTIFICATION**

Port Blair, dated the 11<sup>th</sup> May, 2017.

No. 57/2017/F.No.14(E)/15(7).— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India read with the Govt. of India, Ministry of Home Affairs, New Delhi, Notification No. U-14039/2/83-ANL dated 21<sup>st</sup> February, 1985 and in concurrence with UPSC vide letter No. F.3/30(16)/2011-RR dated 03.05.2011 and in pursuance of DOPT's OM No.AB.14017/13/2016-Estt.(RR) dated 9/8/2016, the Lieutenant Governor (Administrator), Andaman & Nicobar Islands, hereby make the following **Amendment** to the Recruitment Rules to **Group 'B' Gazetted** post of '**Assistant Mill Manager**' borne in the Department of Environment & Forests, Andaman and Nicobar Administration published in the A & N Extraordinary Gazette Notification No. 152 dated 18<sup>th</sup> May, 2011.

**1. SHORT TITLE AND COMMENCEMENT : -**

- (i) These Rules may be called the Andaman and Nicobar Administration (Group 'B' Gazetted) post of '**Assistant Mill Manager**' in the Department of Environment and Forests Recruitment (**Amendment**) Rules, 2017.
- (ii) They shall come into force on the date of their publication in the Official Gazette.

**AMENDMENTS**

2. (i) The existing **Column-4** of the schedule appended to the Recruitment Rules (hereinafter called for brevity as the "said Recruitment Rules") shall be substituted as under:-

- (ii) The existing entries against **Column-12** of the schedule shall be substituted as under:-

**Promotion :-**

Assistant Constructional Engineer and Superintendent Timber Treatment Plant with 5 years regular service in the grade in the scale of **Pay Matrix Level of 06 (Rs. 35400-112400)**.

**Note : 1.** The eligibility service shall continue to be the same for persons holding the feeder posts on regular basis on the date of notification of these rules.

**Note : 2.** Where juniors who have completed their qualifying/eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying/eligibility service by more than half of such qualifying/eligibility service, or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade alongwith their juniors who have already completed such qualifying/eligibility service.
