MEMORANDUM

The Central government vide its Gazette Notification No.686 dt.6th June 2007, has constituted the tiger and other endangered species Crime Control Bureau (known as the Wildlife Crime Control Bureau). The Bureau is headed by the Director, Wildlife Preservation, and Govt of India who is the Ex- Officio Director of the Bureau. The headquarter of the Bureau would be at New Delhi, Mumbai, Chennai and Kolkatta has been made a part of the Wildlife Crime Control Bureau. In addition another Regional Office has now been set up at Jabalpur; Madhya Pradesh called the Central Regional Office. It will have jurisdiction over Madhya Pradesh, Chhattisgarh, Jharkand and Orissa.

Under this regional office with jurisdiction in the States of Andhra Pradesh, Kerala, Karnataka, Tamil Nadu, Andaman and Nicobar, Lakshadweep, Pondicherry, there shall be one sub-regional office at Cochin, and one Border Custom Post at Ramanathapuram, Tamil Nadu. Besides assisting and advising Customs in the inspection of consignments of Wildlife and plant products under the Wildlife (P) Act, 1972, CITES & foreign Trade Policy governing such items, acting as Assistant Management Authority of CITES (Regional Deputy Director only) the functions of the Wildlife Crime Control Bureau shall be collect, collate and disseminate intelligence related to wildlife crime to the States and other enforcement agencies for immediate action so as to apprehend the criminals and establish a centralized wildlife crime data bank.
