NOTIFICATION

Port Blair, dated the 11th May, 2017.

No. 62/2017/F.No.14(E)/15(7).— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India read with the Govt. of India, Ministry of Home Affairs, New Delhi, Notification Nos. U-14039/2/83-ANL dated 21st February, 1985 and in concurrence with UPSC vide Letter Nos. F.3/30(25)/2010-RR dated 21.01.2011 and in pursuance of DOPT's OM No.AB.14017/13/2016-Estt.(RR) dated 9/8/2016, the Lieutenant Governor (Administrator), Andaman & Nicobar Islands, hereby make the following **Amendment** to the Recruitment Rules to **Group 'B' Gazetted** post of **'Legal Assistant'** borne in the Department of Environment & Forests, Andaman and Nicobar Administration published in the A & N Extraordinary Gazette Notification No. 61 dated 9th February, 2011.

1. SHORT TITLE AND COMMENCEMENT: -

- (i) These Rules may be called the Andaman and Nicobar Administration (Group 'B' Gazetted) post of **'Legal Assistant'** in the Department of Environment and Forests Recruitment (**Amendment**) Rules, 2017.
- (ii) They shall come into force on the date of their publication in the Official Gazette.

AMENDMENTS

2. (i) The existing **Column-4** of the schedule appended to the Recruitment Rules (hereinafter called for brevity as the "said Recruitment Rules") shall be substituted as under:-

- (ii) The existing entries against **Column-12** of the schedule shall be substituted as under:-

Deputation: Officers of Central/State Governments/Union Territories:

- (a) (i) holding analogous posts on regular basis in the parent cadre/department
(OR)
(ii) with 5 years service in the grade rendered after appointment thereto on regular basis in the **Pay Matrix Level of 06 (Rs. 35400-112400)** or equivalent.
(OR)
(iii) with 11 years service in the grade rendered after appointment thereto on regular basis in the **Pay Matrix Level of 05 (Rs. 29200-92300)** or equivalent in the parent cadre/department

And

- b) Possessing the educational and other qualification prescribed for direct recruits under Col.8. (The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Govt. shall ordinarily not to exceed 3 years. The maximum age limit for appointment on deputation shall be not exceeding 56 years as on the closing date of the receipt of applications).
