- (a) Length, 6 metres and up will be charged 33 ^{1/3} % extra.
(b) Fixed length- all sections, 25 % extra will be charged.
(c) Width over 30.0 cm or special sizes, will be charged 33 ^{1/3} % extra, except in squares and fitches.
(d) Length between 51 cm to 179 cm will be charged 20 % less than the above rates for the sizes other than quoted at (c).
(e) Rebate on incidental sizes of timber to extent of 25% in all categories shall be allowed for the year 2017-18. The incidental sizes of sawn timber are of width & thickness as (2.5 cm x 1.5 cm, 2.5 cm x 2.5 cm, 4 cm x 1.5 cm, 4 cm x 2.5 cm, 4 cm x 4 cm, 5 cm x 1.5 cm, 5 cm x 2.5 cm, 5 cm x 4 cm, 8 cm x 1.5 cm, 10 cm x 1.5 cm).
