2. Incomplete applications, and application without attested copies of certificate especially the Degree Pass Certificate (Final or Provisional) issued by the concerned University or College authorities will not be entertained.
3. Equal preference will be given to the candidates who have taken Degree from the Local Colleges as well as Mainland colleges, subject to the condition that the candidates belongs one of the five categories laid down in the Govt. of India, Ministry of Home Affairs Order dated 30/05/1996.
4. The following attested copies of certificates are to be attached with the application form, in serial:
 - (a) Certificate of passing AISSCE (Class XII).
 - (b) Age proof certificate (Xth Pass Certificate).
 - (c) Local Certificate issued by the Revenue Authority.
 - (d) Schedule Tribe Certificate (in respect of Tribal Candidate).
 - (e) Degree/Provisional Certificate with statement of marks issued by the University or College Authorities.

PwD : 3% seats are reserved for PwD candidates on interlocking reservation basis i.e. horizontal reservation cuts across vertical reservation (various categories of students in A & N Islands).
