PRESS NOTE

Allotment of Professional/Technical/Non-Technical Courses at Mainland Institutions for the academic session 2017-2018

It is notified for information of all concerned that the allocation of seats and eligibility criteria in various disciplines from the Govt. of India/ State Govts./ Concerned Institution are awaited. However, in anticipation of allocation of seats in various disciplines by the Ministry of HRD, Ministry of Health & Family Welfare and State Govts., the A&N Administration has initiated pre-requisite arrangements for distribution of following Professional/ Technical/Non-Technical Courses (Reserved Seats) in the different institution/ College at mainland under various categories for admission during the current academic session 2017-18 based on the last year (2016-17) allocation:-

Candidates should have appeared and qualified National Eligibility cum Entrance Test-UG (NEET-UG)-2017 for allotment of Central Pool MBBS and BDS seats reserved for the students of A&N Islands. The said MBBS & BDS seats under Central Pool quota will be allotted category-wise to only those candidates who qualify in NEET-UG as per the Qualifying criteria described in the Information Bulletin of NEET-UG 2017 will be considered for admission to MBBS Course.

(b)	(i)	BAMS	Code 03	3 seats

For BAMS course, the candidate should have passed All India Senior Secondary Certificate Examination (XIIth Class) with 55% marks in 10+2 (Physics, Chemistry, Biology).

For BHMS courses, the candidates should have appeared and qualified National Eligibility cum Entrance Test-UG (NEET-UG)-2017 for allotment of Central Pool BHMS seats reserved for the students of A&N Islands. The candidate should also have passed All India Senior Secondary Certificate Examination (XIIth Class) with 55% marks in 10+2 (Physics, Chemistry, Biology). For ST candidates 45% marks. The said BHMS seats under Central Pool quota will be allotted to the qualified candidates category-wise based on the minimum qualifying marks in the entrance examination.

(c) Hotel Management Code 16 10 seats

For the above courses, the candidates should have passed the 10+2 stage examination or equivalent examination in any stream with English as a compulsory subject with at least 50% marks in aggregate, relaxable upto 5% in case of ST candidates. Candidate should not be more than 22 years of age as on 01/07/2017, relaxable upto 25 years for ST candidates.

**(d) Printing Technology/
Photography/
Multimedia Technology Code 23 4 seats**

Candidates must have passed the Madhyamic or equivalent 10+ exam with Maths and Physical Sciences from a recognized Board of Secondary Education. The candidates should have a minimum of 60% marks on Maths and Physical Science taken together. They should also be able to communicate/write in English. The maximum and minimum age is 21 and 15 years respectively as on 1st Jan, 2017 with 3 years upper age relaxation for ST candidates.

- (e) (i) Diploma - 1 Code 29 4 seats
(Electronics & TV, Textile Process
and Cinematography)**
- (ii) Diploma - 2 Code 30 8 seats
(Diploma Pharmacy)**
- (iii) Diploma - 3 Code 34 18 seats
(Production, Electronics & Communication,
Man-made Fiber Technology, Electronics &
Telecommunication, Architecture and
Industrial & Electronics)**

For the above diploma courses, the candidate should have fulfilled the following eligibility criteria:-

- (i) Diploma-1 - XIIth pass (AISSCE) with 50% marks in Maths separately and 50% marks in Physics, Chemistry and Maths put together.
- (ii) Diploma-2 – XIIth Passed (AISSCE) with 50% marks in Physics, Chemistry and Biology(aggregate).
- (iii) Diploma-3 - Xth pass with 50% marks in Maths and 50% marks in General Science and Maths put together on the basis of marks obtained/ Grade Points.

(f) B.Sc. B.Ed. Code 56 3 seats

For B.Sc B.Ed course, the candidates should have registered as well as appeared in the Common Entrance Exam-2017 conducted by Regional Institute of Education and should have passed in +2 Science stream with minimum 50% marks in aggregate. The candidates should have either the subject combination of (a) Maths, Physics and Chemistry or (b) Biology, Physics and Chemistry at +2 level candidates should have passed +2 Examination in science stream. Candidates who have passed +2 exam before 2015 will not be considered for admission.

(g) BL Integrated Course Code 62 2 seats

For the above course, the Candidates should have passed the qualifying examination in (10+2) courses for schooling and have secured not less than 50% marks in the aggregate in case of General candidates (45% in case of ST candidates). Candidate should not have completed 20 years age as on 01/07/2017 (22 years for ST candidates).

(h) General Nursing Code 63 10 seats

(i) Bangalore – 5 (Female unmarried) (ii) Kolkata – 5

The candidate proposes to apply for the above course are required to be fulfilled the following state-wise eligibility criteria:-

- (i) The eligibility requirement in Bangalore, the candidate must be 10+2 passed equivalent board all over the country i.e. Science, Arts and Commerce and 40% score in English (for ST 35%). The Candidates should have completed 17 years as on 01.09.2017 and not exceed 35 years.
- (ii) The eligibility requirement in Kolkata, the candidate should have passed 10+2 examination. Candidate age must be in between 17 years-27 years as on 01/01/2017.

(i) **B.Sc. (Nursing) Code 64 02 Seats**
Female (unmarried)

The candidate proposes to apply for the above courses are required to be fulfilled the following state-wise eligibility criteria:-

- (i) **Kolkata** – Candidates should have passed 10+2 examination from a recognized board, and must have aggregate 50% marks in the subjects Physics, Chemistry, Biology & English (PCBE) in case of General Candidate (45% in case of ST candidates). The minimum age of the candidates should be completed 17 years as on 31/12/2017 and maximum age limit is 28 years.
- (ii) **Kerala** – Candidates should have passed 10+2 examination from a recognized board with 50% marks in Physics, Chemistry, Biology and English (PCBE) put together. In case of ST candidate, 40% aggregate marks in PCBE. Candidate should have completed 17 years of age as on 31/12/2017.

(j) **Para Medical Courses Code 65 05 Seats**

Eligibility requirements for Para Medical Courses :-

The Candidates who proposes for any of the above course should have passed the +2/Higher Secondary/Pre-degree or equivalent examination with Physics, Chemistry and Biology as optional subjects for admission provided that they have secured an aggregate of 50% marks in optional subjects. Relaxation of 10% marks will be allowed to candidate of ST. Applicant should be within the age of 17 to 30 years as on 31.12.2017.

(k) **B.Sc (Agriculture) - Code 81 08 Seats**

The candidates proposes for the above course should have passed in the AISSCE (10+2) with 55% aggregate in any of the combination of four subjects:-

- (i) Maths, Physics, Chemistry, Biology
- (ii) Physics, Chemistry, Botany, Zoology
- (iii) Physics, Chemistry, Biology with a fourth (elective) subject viz., Biotechnology/Microbiology/Bio-Chemistry/Home Science.

For ST candidates, a pass in qualifying examination with four required subjects

NB:- Candidates should not have completed the age of 21 years as on 01.07.2017. For ST candidates, there is no age limit.

(l) **B.Sc (Horticulture) - Code 82 05 Seats**

The Candidates proposes, for the above course should have passed in the AISSCE (10+2) with 55% aggregate in any of combination of four subjects:-

- (i) Maths, Physics, Chemistry, Biology
- (ii) Physics, Chemistry, Botany, Zoology
- (iii) Physics, Chemistry, Biology with a fourth (elective) subject viz., Biotechnology/Microbiology/Bio-Chemistry/Home Science.

For ST candidates, a pass in qualifying examination with four required subjects

NB:- Candidates should not have completed the age of 21 years as on 01.07.2017. For ST candidates, there is no age limit.

1. Eligibility criteria for some courses as defined above are based on the last year allocation (2016-17) the same is subject to change as per revised criteria of the Institutions/College, if any.
 2. The marks obtained by the student in practical examination will not be counted while preparing Merit list for allotment of reserved seats in professional, technical and non-technical courses on the mainland institution/colleges.
